#### ITEM 5 - CONFERENCE OFFERING

The conference offering has two aspects this year – a monetary offering that will go to help La Roca BIC begin a school for special needs children, and a collection of food pantry items (see list below) that will go to Community of Faith BIC who partners with Solomon's Mission, a non-profit organization based in Buchanan, VA that operates a thrift shop and food pantry to aid those in need throughout their community.

#### Offering Project 1: La Roca – A School for Those with Special Needs

When it comes to helping people with special needs, one thing La Roca knows is that it all starts with community. For several years, the church has held a Sunday morning class for people with special needs. Families within the community of Roanoke who have special needs children gravitate toward the church because it is a place they can go to be accepted and ministered to.

La Roca is partnering with <u>Masterpiece Alliance</u>, a non-profit organization that focuses on children and adults with special needs. La Roca's desire is to open a school in the church facility for children with special needs – a place where they can impact families for Christ by providing resources and a place where special needs children can feel safe. The ultimate goal is to not only

help those with special needs, but to integrate them into the church family and allow them to serve in various areas of the church.

#### Offering Project 2: Community of Faith – Food Pantry Staples Donation

Community of Faith has been partnering with <u>Solomon's Mission</u> for some time; collecting and donating various items that are distributed through Solomon's Mission to those in the community who have needs. While the list changes from time to time depending on community needs, the current items being collected by Community of Faith follows. As you enter the church, look for bins or boxes labeled as Food Pantry Items and place your donations there. Current needs include:

Today, we pay tribute to those ministers who served within the conference who graduated from this life to their eternal reward since our last meeting.

#### DWAYNE POTTEIGER (NOVEMBER 21, 1961 – JANUARY 5, 2025)

To meet Dwayne Potteiger was to meet a man with endless smiles, quick wit and a personality you would never forget. His life purpose was to love God, love others and advance the Gospel of Jesus Christ – a purpose he fulfilled with charisma, style and dedication to the One he served so faithfully.

Born on November 21, 1961, Dwayne was the son of Donald E. and Dorothy (Witter) Potteiger, who survive him. Don and Dorothy were missionaries in Rhodesia, Africa. Dwayne lived there between the ages of nine and



fifteen. He later went on to attend God's Bible School (GBS) in Cincinnati, OH, graduating in 1985. Prior to graduating, he met and married the love of his life, Rhonda (Kindy) in 1984.

While at GBS, God called Dwayne to preach the gospel message. Following his graduation, he pastored Dallas Center BIC Church from 1985-1989. From 1989-1994, he served on the staff at Skyline Wesleyan Church in Lemon Grove, CA. During this period in his life, Dwayne was diagnosed with brain cancer and given less than a year to live. But he didn't listen. In 1992, he earned his master's degree from Azusa Pacific University. In 1994, he and his family moved to Denver, CO where he was an evangelist for Kingdom Building Ministries (KBM). While with KBM, he underwent two more brain surgeries. From 2000 to 2008, he served as the senior pastor at Antrim BIC Church near Chambersburg, PA. Moving on from Antrim, he went to Mishawaka, IN to serve as the senior pastor at the Gospel Center Missionary Church until 2013.

Even though he endured a tremendous amount of adversity, Dwayne never allowed his health to stop him from sharing the good news of salvation through Jesus Christ. After leaving the pulpit, he attended Nappanee Missionary Church where he continued to fulfill that purpose.

In addition to his parents, Dwayne is survived by his wife of 40 years, two daughters, ten grandchildren, and two brothers – plus an incredible legacy of fruit from a life that made an impact on so many.

Dwayne graduated from the struggles of this life to his eternal reward on Sunday, January 5, 2025.

Regarding those who work hard in the ministry of leadership in the Church, the Apostle Paul said, "Hold them in the highest regard, in love, because of their work". Therefore, we uphold Rev. Dwayne E. Potteiger in highest regard, in love and we give thanks to God for his contribution to the Brethren in Christ Church and the Kingdom of our Lord Jesus Christ.

Thank you for the opportunity to serve on the General Conference Board (GCB). I am filled with gratitude to serve in this way as the member from the Allegheny Regional Conference.

Each year, the GCB meetings take place during the months of February and September. In 2024, both of these meetings took place at the Brethren In Christ U.S. Offices in Mechanicsburg, PA. Prior to our meetings, we received and reviewed reports to help prepare us as we come to the table for dialogue, the opportunity to ask questions, receive clarifications, and for voting on various items.

The first day we meet together, the GCB has combined meetings with the Leadership Council (LC). The second day is dedicated to GCB work. Sometimes beyond these meetings, it may be necessary to have zoom meetings and do electronic voting. This year involved multiple times of electronic voting on various items of business. Some of these included the approval of GCB officers, BICF board member, Messiah Lifeways board member, Housing allowances, and property sales in Susquehanna and Atlantic conferences.

At our regular meetings in 2024, we approved the finance, governance committee and development reports. We also approved the closure of Story Church and Bethel Merrill BIC Church.

Last year we held our BIC U.S. General Assembly meetings and gathering in Ohio. A huge thank you to the BIC U.S. staff team led by Mitch Martin and Tammie Gitt, as well as Bishop Lynn Thrush and his team in the Great Lakes Conference. We appreciated their diligent work with the details, so all who attended and participated could have a blessed time. We hope you were able to connect with old and new friends during your time in Ohio

The countdown continues...Our 250th Anniversary is just three years away with Project 250 being our guide for the journey. If you want to know more about Project 250, please go to the BIC U.S. website to learn more.

#### ITEM 11 – BIC U.S. REPORTS

#### NATIONAL DIRECTOR'S REPORT FOR 2024

As you may recall, in past reports I have highlighted the fact that the ministry of BIC U.S. occurs primarily in the congregations across the country and the missions around the world. We are in the

process of gathering the end-of-year reports from congregations. I am happy to be able to report that we see indications of increased health and growth in some congregations. We give thanks to God for this. We also appreciate the work of the individuals who are the channels through whom God is at work. Some congregations continue to experience challenges and difficulties, and we remain in prayerful support of those congregations.

Project 250 and Thriving Congregations

We continue to work on these projects. Much of the work of Project 250 is done at the regional and congregational level. Thriving Congregations continues to find its feet and we have received encouraging words of appreciation from congregations, pastors, and leaders that are part of Cohort A. Jennifer Lancaster continues to give excellent leadership and support to these projects.

#### **Church Planting and Multiplication**

We continue to prayerfully discuss how we can increase our church planting and multiplication efforts. Financial resources are available to support these efforts. A taskforce of Leadership Council (LC) members organized a consultation that was held in Kansas City in the Fall of 2024 and continues to plan ways to increase these efforts.

Some items that have emerged in our conversations are:

- 1) How can we best develop and recruit and support church planters/multipliers?
- 2) In light of new models of ministry and church, what are the essential characteristics/qualities/organizational structure of a congregation/church?
- 3) Many of our historic church plants, and many of the newer models of multiplication, do not have the typical financial structures of the more "traditional" church plants. This often means they are more dependent on outside funding (and for longer periods of time) and are much less likely to give back to support our Common Ministry.
- 4) Some congregations have creatively started additional nonprofit ministries as part of the ministry of the church. How can we best organize, structure, and govern these new entities? Also, are these new entities expected to contribute to support our Common Ministry?

#### Missional and Financial Health and Future Viability

In addition to the financial questions listed above, the finance reports will highlight that the long-term trajectory of congregational giving to support our Common Ministry has not kept up with the inflationary pressures that are part of Common Ministry expenditures. If this trajectory continues, we will become increasingly dependent on other streams of income.

LC has begun to discuss some organizational issues from both a ministry and financial viability perspective. From a ministry perspective, and a financial viability perspective, is the current regional conference structure optimal for future mission and ministry? These questions were raised and discussed at length by LC and General Conference Board (GCB) approximately 18 years ago. Several alternatives were suggested. It may be time for us to discuss these matters again.

#### **Global Ministry**

Please be sure to read the report from Jonathan Lloyd, Director of BIC U.S. World Missions. I am deeply grateful to Jonathan and the entire World Missions team and our missionaries around the world for all of the work they continue to do.

As we are all aware, our world continues to change, and the pace of change is increasing. Some of the factors that impact the global ministry of the Church include:

- some countries becoming less open and even closed to the gospel and missionaries,
- the movement of people around the world, including increased numbers of various people groups within the United States,
- the growth of the BIC outside of North America and increasing number of applications from pastors outside of the US for pastoral vacancies inside the US,
- other BIC national conferences raising and sending missionaries to other countries, including North America.

Combined with these global realities, the International Brethren in Christ Association (IBICA) has not been able to fulfill its missional objectives. Due to the death of one board member (Bijoy Roul), and term limits for three members (Danisa Ndlovu, Thuma Hamukangandu, and Jose Otamendi), only two board members (Alan Robinson, BIC U.S., and Todd Lester, BIC Canada) are able to continue on the board.

All of these factors contribute to the sense that we are entering a period where the nature and operational structures of the global BIC will need increasing prayerful conversation.

#### 2028 Global Assembly

We continue to plan for our 2028 General Assembly, which we now refer to as the 2028 Global Assembly. Our hopes and prayers are that this gathering will be helpful to the global BIC to celebrate 250 years of ministry but also prayerfully discuss and discern future global ministry.

We have begun to budget the estimated costs of the 2028 Assembly, particularly the costs of inviting and bringing 250 people from outside North America. We are delighted that donors have committed to giving \$400,000 to help support this important gathering. We expect that this will cover around 50% of the expected costs. We continue to ask congregations to contribute an additional \$250 per year until 2028 designated for the 2028 Global Assembly. These contributions will help to make the event possible and will mean that every congregation has shared in helping our global brothers and sisters to be represented at the Global Assembly.

#### **Leadership Council Terms**

I have been in conversation with each member of LC whose current term ends in July 2026. These conversations continue and will also include the various BODs in each of the respective regions.

#### **BIC FOUNDATION REPORT FOR 2024**

The Brethren in Christ Foundation (Foundation) exists to serve the Brethren in Christ U.S. (BIC U.S.), its congregations, and members through lending, investing, charitable giving instruments, and servicing the BIC U.S. pension plans. We continue to evolve and adapt to ensure the continued service and support to the BIC U.S.

#### **Lending Activities**

During 2024, the Foundation funded 7 new loans totaling \$2.4 million.

We had the opportunity to work with a ministry that seeks to aid the restoration of men who struggle with addiction. The ministry wanted to acquire a property where the men could live during their treatment. After several years of searching, they were able to locate an 8-acre property with several buildings that would be very advantageous for the ministry and the men they help. Since purchasing the property, they have renovated and upgraded the property and expect to begin accepting clients soon.

In another instance, we were approached by a congregation who had a loan from a conventional lending institution. After discussing their financing with the Foundation, we were able to refinance their mortgage. The refinance has relieved financial pressure on the congregation allowing them to evaluate their future ministry with a more stable financial situation.

Our loan portfolio remains secure. We are blessed to have borrowers who are responsible for their finances. As of December 31, 2024, all loans in our portfolio are either current or paid ahead. We do not take this fact lightly.

During 2024, 11 borrowers paid off their loans early. This totaled \$1.7 million. We expect this trend to continue in the future.

As we enter 2025, we continue to see strong interest in new loans. Currently, we have four loans in underwriting. In total, we anticipate distributing approximately \$3.8 million in the first quarter. That does not include potential loan requests that may come about during the year.

#### **Securities**

To support this robust lending activity, we continue to explore ways to raise capital. We do this by selling securities to eligible investors.

During 2024, the Foundation introduced our Youth Savings Certificate program. This certificate is meant to attract new investors who wish to save for college or other long-term needs for their children or grandchildren. One unique feature of the certificate is the ability to continually add to its balance. We are very pleased with the launch of the program. We have sold 133 Youth Savings Certificates and continue to see ongoing additions to the balance for most of those certificates.

We have also modified our Demand Certificates to establish progressive variable interest rate tiers for interest rates payable on the Demand Certificates based on the total principal amount

invested. As an investor increases the amount invested in the Demand Certificate, the rate of return will increase. This is aimed specifically at congregations, organizations and individuals who are saving for the future whether it be a rainy-day fund, building fund, down payment for home purchase, or similar purposes.

On December 31, 2024, the invested funds in Brotherhood Loan Fund securities totaled \$46,921,406. This is an increase of nearly \$1 million over 2023.

#### **Matching Grants**

In 2024 the Foundation awarded 12 matching grants for outreach initiatives, totaling over \$16,000. Those programs included Racial Healing & Justice Cohort, establishing a community outreach center, a youth awakening festival, a community trunk or treat, and a variety of community gatherings.

#### BIC U.S. 403(b)(9) Plan

The Foundation provides administrative services for the denomination's pension plan.

As TPA, the Foundation is responsible for the day-to-day operation of the plan. On a daily basis, we assist congregations and employees with their questions regarding enrollment, contributions, disbursements and loans. We have continually upgraded technology to improve access to the plan for both employees and employers.

The future holds many opportunities to expand the ministry of the BIC U. S. and we at the Foundation are excited to be a part of that expansion

#### **DEVELOPMENT UPDATE**

Since joining the BIC U.S. team in November of 2021, a priority project has been to develop the BIC U.S. Legacy Society and identify people who have made a gift in their estate plans in support of BIC U.S. ministry. Currently, we have 120 members. The goal is to identify at least 250 members by our Global Assembly gathering in 2028. The BIC U.S. Legacy Society represents approximately \$4.4 million in future funding for all aspects of BIC U.S. ministry.

Over the summer, I learned of two resources that I feel will help continue the growth of a culture of generosity within the BIC U.S. In turn, these tools should expand visibility of the BIC U.S. Legacy Society and grow membership. I am in the process of connecting with the Bishops to review these resources and connect with pastors interested in utilizing these tools in their congregations.

The first exciting resource is an organization called Generous Giving.org. Generous Giving seeks to address the increasing gap between the wealth of individuals and ministry funding. As our church members' wealth has increased, giving to the church has not. Through a generous grant, Generous Giving.org has developed a program called "Journey of Generosity" and a network of facilitators to lead day-long workshops around the concept of generosity. The interesting thing about these workshops is that there is absolutely NO ask. Period. Here is a quick video to explain. Informal research by the National Christian Foundation shows that charitable giving has grown over 30% in people who attend a Journey of Generosity.

The second organization I have learned about is LegacyWise. We have all heard about online Will planning tools that allow people to create simple estate plan documents at a reduced cost. While the concept of making it easy for people to create a will and estate plan documents easily and at a low cost is admirable, there is often no assistance to help people through the process. That is where LegacyWise shines. LegacyWise offers workshops hosted by a facilitator who walks participants through the process of creating individualized, state-specific documents. It is possible to create a full set of legal documents to print and notarize after the workshop. The facilitator would also follow up with those who do not fully complete their documents at the workshop to encourage participants to finalize the documents within weeks of participation. There is a cost, but it is reasonable for the participants. The vision of LegacyWise is to see guardianship established for minor children, and charitable giving in place to fund future ministry. Post-workshop statistics show that a substantial percentage of participants make gifts to the hosting organizations.

I am collaborating with the Communications team and recently recorded video pieces to provide information on topics like Qualified Charitable Distributions from an IRA, gifts of appreciated stock, and membership in the BIC Legacy Society. These pieces will be available for congregations and individuals to use.

#### SHARED SERVICES

BIC U.S. shared services exists to provide the various ministry areas of Brethren in Christ U.S. (BIC U.S.) and the Brethren in Christ Foundation (Foundation) with communications, human resources (HR), development and administrative and financial services.

#### **Communications**

The communications team provides a vital ministry of facilitating conversation among the BIC U.S. family. Through articles, videos, print resources, and digital communications, the communications team seeks to encourage, edify, and educate our constituents.

Online Communications - Digital spaces continue to provide us with opportunities to communicate broadly. We sent six issues of our **Connect** newsletter to around 4,695 recipients

#### **Human Resources**

The Human Resources department continues to be an important component of Shared Services' support of the local, regional, national and global ministry of BIC U.S.

One of the significant responsibilities of Peter Guinther, human resources administrator, is keeping our staff and missionaries trained in various areas. In 2024, staff and missionaries received training on security and risk management and sexual harassment prevention. After a long, ardent process, we have finalized the ministerial misconduct policy, receiving approval from both Leadership Council and CMD. Since finalizing the policy, we have created an FAQ resource that attempts to anticipate questions that individuals may have and provide the answer based on the policy and procedures. We have also created a training syllabus for Response Team members and hope to train our first group of Response Team members in 2025. As part of the website rebuilding process, we will be creating a section of the website which will host the policy and procedures and also include an online form for reporting potential concerns of misconduct.

In addition to efforts, human resources continues to work with all departments of BIC U.S. to help with hiring and onboarding of office staff members and the deployment of missionaries. Equally important, human resources works with staff members and missionaries as they conclude service with BIC U.S.

Lastly, Peter continues to be available to congregations and pastors to provide insight on topics such as health insurance options, child protection policies, and church security resources. We are

committed to providing resources to congregations and pastors and coming alongside them as they seek information on various HR issues facing the church.

#### **Development**

Mark Templeton continues to serve as our development officer. We are grateful to have Mark on board as he has done an excellent job of connecting with donors, pastors and key stakeholders. Mark also represents BIC U.S. at various events throughout the year. Mark continues to research and develop new tools in the area of planned giving and donor development. Please refer to Mark's written report for more details about the work he has been doing.

#### **Finance**

The finance team continues to be vital to the success of the common ministry of the BIC U.S. The team seeks to balance the tasks associated with internal operations such as payroll, expense reimbursements, and keeping accurate records with the tasks that have more of an external focus such as: donor relations, training and consulting with pastors and congregation treasurers, and providing record-keeping services for both the Great Lakes Conference and the Pacific Conference.

Over the course of the year, our team processes nearly 1,750 outgoing payments and over 9,000 contributions from BIC U.S. congregations and donors. In addition to the day to day processing of incoming and outgoing payments, our team plays an important role in supporting the work that happens around the world. In 2024, our team processed 216 international wires in 15 different currencies to 16 different countries. A significant undertaking this year was releasing over \$132,750 in Global Compassion funds for 15 different needs in 8 countries.

Our finance team took on a new task of managing and tracking grant funds received for the Thriving Congregations Initiative. We are required to submit annual reports, participate in periodic webinars and trainings and submit budget revisions as our grant program changes.

In August, we welcomed Stephen Badiger to our team. Stephen serves primarily with World Missions but given his finance training and background, I have been able to collaborate with Stephen on a number of finance related projects, including an initial proposal for providing accounting and payroll services to BIC U.S. church plants and existing congregations.

We continue to offer assistance and resourcing to our pastors and treasurers in the area of church finance. I have been working with more and more congregations to provide salary benchmark reports for various current and prospective positions. BIC U.S. collects salary and benefits information from BIC congregations as part of our end of year report process. We then compile the data and build various reports for Bishops with analysis on the compensation of pastors and congregational staff members in their region. We also create benchmark reports for congregations upon request using this data. Additionally, we purchase access to a national church salary tool to provide additional benchmark reports to congregations. Our goal is to help boards assess the compensation of their pastors and staff and provide counsel when invited to do so.

#### **Education and Training**

Shared Services continues to take an active role in enhancing existing education opportunities of BIC U.S. and providing additional training opportunities in the form of webinars. We have launched a self-paced course to help prospective pastors and lay leaders become more familiar with the beliefs and values of the Brethren in Christ U.S. This course, <u>Getting to Know the BIC</u>, has also been

adopted by Leadership Council as a requirement for credentialing. Additionally, we built new web-based forms for ministerial credential applications and the renewal of ministerial credentials. This replaces paper forms and allows for automated dissemination of information to respective parties. We are committed to enhancing the experience of our pastors as they move through the credentialing process.



Our Shared Services team conducted 6 webinars in 2024 on a variety of topics (noted in the graphic) with a total of 135 individuals attending one or more of the webinars. All webinars were recorded and are available for viewing in our multimedia library. Webinars provide an excellent opportunity for our team to resource pastors and leaders with expertise that we have and also helps to build connections between denominational staff and congregational leaders. We hope to continue offering webinars on topics that are impacting our congregations. We are always welcome to topic suggestions.

I am grateful to serve alongside the Shared Services team to support the local, regional, national and global ministry of BIC U.S. Our team continues to believe that Shared Services is a great expression of the value of doing ministry together compared to on our own.

#### WORLD MISSIONS

"Wherever Great Commission obedience falters, the church's vibrancy begins to wane. Gospelprivileged peoples who do not keep the message flowing outward will eventually lose it themselves." ~Steve Richardson

I came across this quote last year, and it has remained a backdrop for our missions work ever since I heard it. I'm grateful to be part of a church family that does continue to prioritize sharing the gospel message "outward." It is uplifting to see the creative ways that this happens through congregations and individuals here in the U.S. and in countries around the world. I'm increasingly encouraged as I see BIC leaders in many nations strengthening, supporting, training, and sending workers committed to carrying the gospel message with them wherever they go.

Below you will find a summary of the highlights of our Common Ministry in global missions. I cannot stress often enough or loudly enough that these are YOUR highlights. The mission we carry out globally is an overflow/outward flow of the same mission you carry out in local churches as you participate in disciple-making.

#### **Missionary Highlights**

It's difficult to summarize the individual highlights and challenges our nearly 70 adult mission workers experienced in 2024; each of them has stories of joy and hardship. Instead, I encourage you to connect directly with them. As I think about the relationships between BIC cross-cultural workers and our churches in the U.S., I long for the words of Colossians 1:3-14 to be a true word from you to them and from them to you. If you will pray with joy and thanksgiving for each other, asking God to strengthen each other as you all minister in the places to which you are called,

then we can all rejoice as the gospel continues to grow and bear fruit through all of us! I believe you will be an encouragement to each other as we engage God's mission together.

#### International Leadership Development and Collaboration

My favorite verse in the Bible is in John 17, when Jesus prays that his followers would be united as proof of his divinity. This year, several significant collaborative trainings were held with representatives from multiple nations uniting in fellowship, worship, and work. As we continue to see fracturing and animosity in our world, we have an opportunity to demonstrate the divinity of Jesus as we love each other and work together well.

In March of 2024, participants from at least four nations gathered in Colombia for a leadership training event hosted by the Bogotá congregation. Many of these leaders had never met before. They were enthusiastic in their appreciation for the opportunity to meet other BIC leaders and to participate in training together. A similar training is planned for March 29-30 of 2025. There will be three individuals collaborating to teach the course, each of whom is from a different nation.

In August the Thai BIC church hosted a training with 29 participants from 5 different nations. The feedback was overwhelmingly positive, and participants are asking for a similar training to take place in 2025.

Both training courses took significant administrative planning and effort. We are grateful for God's faithfulness and the hard work of many individuals who came together to make these experiences possible.

In addition to these group trainings, each year we receive proposals from international churches and missionaries to assist with funding for leadership development scholarships and seminars. Our Leadership Training Endowment allows us to grant funding in support of many of these requests. Some of the highlights of this work in 2024 were:

- leadership and discipleship seminars held in Botswana and led by trained and experienced BIC leaders from nearby Zimbabwe
- young leaders from tribal communities in Ecuador being trained and discipled
- pastors and spouses in Spain receiving training at a seminary in Spain

#### **Short-Term Ministry**

In 2024, 83 people participated in short term mission experiences in Thailand, Colombia, and Dearborn, Michigan. These participants came from 24 different congregations and served by assisting long-term work in strategic, impactful ways. We are increasingly learning how to structure, train, and support short-term work so that the teams can do meaningful ministry during the trip and integrate well into ongoing mission efforts. This enables the long-term workers to effectively follow-up with those in their community after the short-term teams return home. The joy of working with brothers and sisters from a variety of congregations in a cooperative mission outreach is also a significant blessing from this approach.

#### **Missionary Development and Openings**

We currently have 16 people in the Missionary Development Community. After walking with mentors and experiencing significant growth in their own journey as disciples, these individuals

typically go on to serve the church domestically or internationally in significant ways. Our process for sending workers begins by identifying a need, seeing whether the need aligns with our vision and strategic plan, discerning and shaping that need into a mission "post" by missions staff and the Commission on World Missions, and presenting that possible mission post to Leadership Council for approval. There are currently approximately 20 "open positions" with BIC U.S. World Missions. Each represents an opportunity for a person or persons to make an eternal impact through meaningful service. Teachers, pastors, medical professionals, university student ministry workers, engineers, and strong disciples of Jesus who are skilled at bringing support to growing churches are all welcome to contact us for more information. Locations for these positions are in North and South America, Europe, Africa, and Asia.

#### **New Staff**

We welcomed Becky Owen onto the staff team as our member care assistant. In addition to her work with missionaries, she will give specific attention to providing excellent care for missionary children.

Stephen Badiger moved from a remote contracted assignment to begin a full-time position based in the home office. Stephen brings a wealth of experience and a passion for church planting and Kingdom stewardship of finances to his work.

#### ITEM 12 - BISHOP'S REPORT

At almost the exact moment that I began writing this report, I received an email from Tammie Gitt, Brethren in Christ U.S. Administrative Coordinator. Tammie was analyzing the data provided by congregations in their annual reports and she wanted to share a few quick observations. According to the figures that reporters submitted, Tammie noted the following:

- 13 churches in the conference have returned to or exceeded their pre-pandemic average attendance levels.
- Combined average attendance at all Allegheny churches increased by 10% from 2023 to 2024.
- Combined average attendance at Allegheny churches increased by 9% since the pandemic.
- Two churches lost 40% or more of their congregations from 2023 to 2024. Both were smaller churches.
- 1241 conversions were reported in the region since 2019.
- 745 baptisms in the region since 2019.

I especially want to praise the Lord for those last two numbers. Sometimes we can be distracted by the many challenges we face and lose sight of the bigger picture. Rest assured; God is advancing His kingdom. In addition to conversions and baptisms, we could recount many other stories of God providing, protecting, and producing good fruit among us. We have a lot to celebrate.

As is typical in any year, there was more than enough to keep me occupied every day. There were numerous local, regional, and national meetings. I processed thousands of emails, hundreds of phone calls, and a lot of text messages. Some of the standout moments included installing Bruce Ward at Antrim, celebrating church anniversaries at Highland Park and Mt. Tabor, attending General Assembly and the church planting collaborative, regularly attending services at Rios-Martinsburg, ordaining Melissa Beal and Jeremy Spear, as well as many other special occasions.

On the horizon, I expect to process a few pastoral transitions in 2025. In addition to the interim situations at Peace Light, Bethel, Springhope, and Five Forks, we recently started a search at Crossroads, and I expect to begin a search at Highland Park soon. Looking just a bit further down the road, we can expect more transitions as more of our pastors anticipate retiring.

Personally, physically, I'm doing relatively well. I still have occasional flares of an autoimmune disease, but nothing debilitating. I regret that I missed last year's annual meeting due to a stomach bug, but I'm very thankful for how everything went quite smoothly without me. Daryl and I are on the cusp of entering what some call the "retirement years." I'm not sure what the future holds, but I've committed to completing my current term in 2026, and I have said that I am willing to potentially serve for a while beyond that, if invited.

Psalm 16:6 says, "The lines have fallen to me in pleasant places; indeed, my heritage is beautiful." I am very grateful to God for all that He accomplished among us in 2024. I pray that we continue to follow Him closely and learn to know Him better. May He continue to bless us abundantly!

## ITEM 13 – Discipleship Council

Dear Friends,

The Discipleship Council included Sherri Flohr, Shaun Kipe, Joey Wendling, and Bishop Rob. We are thankful for this team and their work in mentoring, training, and developing leaders.

In the summer of 2024 Jacob Swope, from Hollowell BIC, was the Allegheny BIC Summer Intern. Over the summer he had opportunities to learn and grow at Mt. Tabor, Hollowell, BIC Missions Office, Five Forks, New Guilford, The Tide, Trinity Evangelical Fellowship, Paramount, and General Assembly. He also attended an internship summit at the BIC offices. Throughout these experiences he attended board meetings, visited in private homes and nursing homes, preached sermons, worked with youth and children, read assigned books, and helped at outreach events. Both Jacob and the places of ministry provided positive feedback on the internship experience.

The major discussions of the Discipleship Council this year have been about changes to the internship ministry within the conference. These discussions came out of an Internship Summit that was held in Grantham in May 2024 with leadership from the Allegheny, Susquehanna and Atlantic Conferences. It was decided that future interns will have the option of serving for two years. One year the intern would serve the conference in different ministry locations, as we have done in the past. The other year would be focused upon a specific congregation for a summer. This would allow an intern to experience a variety of ministries and specific ministry within a church setting.

Discipleship Council has also discussed and is planning to host a Second Career Summit and intentional mentoring opportunities in the near future. #### ITEM 14 - EVANGELISM COUNCIL

#### Changing Roles and Responsibilities

This past year, the Evangelism Council (EC) continued our discussion about the changing roles and responsibilities of the council.

In October 2024, Bishop Rob, Brad Stutzman & Steve Delaney joined representatives from all 7 regions of the BICUS for a conversation focused on creating a denominational vision for church planting and multiplication.

Over the 3 days we were together, we talked through historical approaches to church planting as well as ongoing trends in church attendance and engagement. These conversations formed the foundation for more focused work on developing a comprehensive, holistic approach to fostering a vision for multiplication within the BIC.

Since that meeting, Leadership Council has discussed the next steps.

To that end, the task force within Leadership Council that has been exploring church multiplication and was instrumental in organizing the gathering has been tasked with continuing the work.

This has led to the EC's continued wide-ranging discussion that includes paradigm shifts in church organization, structure, oversight and talking through the definition of what constitutes a "church"...

Micro-churches, house churches and small groups... Along with more traditional church planting... What is the denomination's role in those? ACBOD's role? EC's role? What does support look like? What does oversight look like?

This conversation will likely be ongoing for some time to come as we pray and listen for the Holy Spirit's lead.

#### ITEM 19 – BOARD OF DIRECTORS

#### A. The Secretary's Report

The Board of Directors (BOD) supports and encourages the work of the councils, the local church, and camps within the Conference. It also provides general administrative guidance for the Allegheny Conference.

The current members are: Rob Patterson (Bishop), John Melhorn (Assistant Moderator), Lawton Jacobs (Secretary), Stan Morgan (Treasurer), Sherri Flohr (Member General Conference Board), Kevin Lay (Member At Large/Discipleship Council Chair), Terry Hoke (MAL), John Walker(MAL), (Discipleship Council Chair), Steve Delaney (Evangelism Council Chair), Lisa Crawford (Ministry Council Chair), Caleb Nowell (Worship Council Chair).

The BOD typically meets three times a year between annual regional conferences. This year was no exception. We met in June, December and January. The December meeting was hosted by Bishop Rob and Daryl in their home. Spouses were invited to join us for the meal. We had a great time of fellowship before getting down to business.

Here are some of the items discussed and decisions made in the past year:

- 1) Annual Regional Conference Allegheny Regional Conference for 2024 was held at Air Hill on April 6. One unusual aspect of the meeting was the absence of Bishop Rob. He was unable to attend due to illness. Joel Gillman was serving as the assistant moderator and did an excellent job leading us through the business of the day. At Air Hill it was announced that the plan was to hold Regional Conference at La Roca in Roanoke, VA in 2025. It is exciting to see this come to fruition.
- 2) The Mt Rock Worship Center Several congregations meet at the worship center and will likely need an EIN number at some point. The BOD approved a recommendation to recognize The Rock as well as all Acts Fellowship Network congregations in the Allegheny Conference as members of the Conference and eligible for EINs.

- 3) Loan Approvals Two loans with the Brethren in Christ Foundation were approved. The Mt Rock Worship Center will use the funds for a solar panel project and Mission Hill will for parking expansion.
- 4) Air Hill's Bylaws Congregational bylaws are to be presented to the BOD for approval. Air Hill's Bylaws were approved at the December meeting.
- 5) Sherman's Valley Parcel Proposal Someone has inquired about purchasing a piece of land across from what use to be Sherman Valley's parsonage. The congregation is not really interested in selling at this point. In order to take the pressure of making a decision off of the congregation, the BOD recommended Sherman's Valley consider leasing the land.
- 6) Proposed Language in the Articles of Faith and Doctrine The BOD received two proposals for the wording of Article II God and Creation in the Brethren In Christ U.S. Articles of Faith and Doctrine. A task force was formed to work on a proposal to present to Regional Conference.

**Budget Proposal 2025** 

Each year the inevitable question of how the conference can operate with budgeted expenditures that exceed the budgeted revenue is brought up. Our fiscal philosophy is that too much money left sitting in bank accounts does no good. We prepare a faith budget using numbers that we believe fit with the ministry that we hope to do. Our expectation is that income will support the vision, but, if not, we will either do less or draw on our surplus.

The Treasurer's Report can be found in Appendix A (pages 45-50) at the back of the agenda.

#### C. Recommendations

- 1. The Board of Directors recommends the confirmation of Don Shenk to serve a third term as Member at Large on the Staffing Council ending in 2028.
- 2. The Board of Directors recommends the adoption of the Budget for 2025 with budgeted revenue amount of \$65,708.00 and budgeted expenditures of \$75,175.00.
- 3. The Allegheny Regional Conference Board of Directors has received requests for a change to be made to the wording of Article II: God and Creation of Articles of Faith in the Manual of Doctrine and Government. In light of these requests, the Board of Directors brings the following recommendation to the Allegheny Regional Conference body. If approved, this recommendation will be given to the General Conference Board as a request to be included in the agenda for General Assembly 2026.

The Allegheny Regional Conference Board of Directors recommend the final paragraph of Article II: God and Creation (Relationships in creation) read:

God gave human sexuality a good place in creation. Being born male or female is integral to who we are. Though both sexes bear God's image fully on their own, each does so in a unique and distinct way, completing one another to fully express our humanity. God has given standards for expression of our sexuality that are necessary for proper relationships among people. Human sexuality is affirmed within the chaste single life or a lifelong marriage between a man and a woman.

The current reading in the 2024 edition of the Manual of Doctrine and Government: God gave human sexuality a good place in creation. Being either male or female is integral to who we are and provides for the full expression of our humanity. God has given standards for expression of our sexuality that are necessary for proper relationships among people. Human sexuality is affirmed within the chaste single life or a lifelong marriage between a man and a woman.

### ITEM 20 - ELECTION OF THE ASSISTANT MODERATOR

The Assistant Moderator will be elected from among the active ministers (Licensed or Ordained) who are assigned and serving in the Allegheny Conference; will be installed at the end of our annual meeting and serve through the following annual meeting. A first nominating ballot will be taken with the three highest nominees being chosen for an election ballot (unless one individual has already received a majority). The election ballot requires only a plurality. Previous Assistant Moderators are not eligible for re-election for five (5) successive years. These persons are Steve Delaney (2020-21), Doug Lichty (2021-22), Jill Thompson (2022-23), Joel Gillman (2023-24) and John Melhorn (2024-2025). These five names are excluded from the following list.



#### ITEM 22 - ROXBURY HOLINESS CAMP

Greetings from Roxbury Holiness Camp. Another great year of ministry is behind us and we are in full swing of another busy year of serving Jesus by serving a variety of guest groups on our campus.

Our calendar remains mostly full and we have a waiting list of groups looking to book their retreat as space becomes available. We thank God for the opportunity to serve the variety of guests and groups from 1 to 1,000.

We received a call last summer from a gentleman named Wilfred wanting to reserve a site in the RV park for a week of fasting and prayer. At the beginning of the week, I was able to stop and talk with him at his RV. We talked a little bit about ourselves and about how we began coming to Roxbury. He has come for many years with Manna from Heaven, one of the large cabin groups. Later in the week, when I stopped again, we spoke further about his life and found out that he is originally from Guatemala. He felt the Lord leading him that week, in a call to return to Guatemala to establish a camp just like Roxbury. He had such a smile on his face as he talked about when he is here, he feels the Holy Spirit on these grounds, and how special Roxbury is to him. Wilfred has returned several times for personal retreat and has begun preaching and live streaming his messages from the cabin that he stays in. His brother came with him and has felt God calling him into full time ministry as well.

We have a group that we have been partnering with for nearly 10 years that serves in secure locations around the world. I will call them KC. They are an anabaptist group that began serving orphans and widows in war torn areas in the Middle East by meeting physical needs, and teaching English as well. As the war in Ukraine has created another opportunity for service, they have been using Hawbaker Legacy Retreat Center as their training location. One specific thing they learn while here is to sweep fields and clear them from land mines. They had a close call when one exploded and destroyed some of their equipment. It is our privilege to be able to discount their bill and partner in their ministry around the world. Join us with your prayers for this group as they raise funds to continue their ministry.

These are made possible because of your prayers and support.

This winter we have also begun 2 new small group ministries. Scones and Scripture, a monthly Bible journaling event for women, and Biscuits and the Bible, a weekly Monday morning group for men. The staff has a growing passion for hands-on ministry and are leading these groups to impact people's lives directly for Jesus.

Looking Forward: Pray for the board as they are working on a plan to eliminate the debt on the Hawbaker Legacy Retreat Center. This building is vital to the ministry of Roxbury, and being able to eliminate the debt would further enable us to develop new ways to develop ministry as God leads.

### ITEM 23 – CHRISTIAN RETREAT CENTER

I believe and trust 2024 was a fruitful year as CRC sought to proclaim the name of Jesus through different ministry avenues. Thinking back to the summer programs, it is a blessing to organize TIMS, youth camps, and family camp.

Our TIMS program, which is where youth groups come to CRC and are then sent out into community, had another influential summer. We were able to send teams to towns in Juniata and Perry County. Work included constructing ramps for an elderly woman and a husband who was confined to a wheelchair, laying new carpet in a child's bedroom, and helping families with yard work. The physical work is always good, but the lasting influence is the relationships that are made between our work teams and the homeowners.

Our youth camps had another year of good numerical growth as we welcomed over 260 campers. During our four weeks of youth camps 9 children made a first-time decision to proclaim Jesus as Lord, 20 campers rededicated their lives to Jesus, and 5 teenagers got baptized during our Teen Camp in the creek at the front of camp. We give thanks for the influence a week of CRC has on the lives of these children. I also pray and trust many other lives were encouraged to keep pursuing Jesus while living in a culture that often promotes values that are contrary to the Kingdom that Jesus announced.

CRC concluded our summer programs with our Family Camp. CRC's team welcomed nine families, which totaled about 50 people. Family Camp has become a great way to end our programs and is a great opportunity for families to be together before another academic year begins.

For the rest of the year, CRC is regularly welcoming churches, families, and organizations for retreats. It's a blessing to welcome our BIC churches for various retreats and to welcome pastors for personal / individual retreat for a time of rest, prayer, and study. This year CRC hosted a Vietnamese Church from Harrisburg, a church from Boston, reconnected with a church from Queens, welcomed a local parachurch ministry that held a young adult retreat, an adult disciple group from Mechanicsburg, and a Bhutanese and Nepalese young adult retreat with participants joining from around the United States. It's a joy to welcome so many people to CRC who live in different parts of the country, represent different cultures, and ethnic backgrounds. It's a great reminded that the Kingdom of God is wide and diverse, but there is great unity for those that fall under the Lordship of Jesus.

Our Project 3,000 campaign continues to be positive as we grow towards financial sustainability. In 2024 CRC paid over \$200,000 in principle on our debt. Our loan is under \$800,000.

As a whole, the Lord continues to sustain & care for our ministry efforts through a camping context. It's an immense joy to serve at CRC with the camp's staff and with the Board of Directors.

### The Tide 2025 Report to the Allegheny Regional Conference

Our core purpose remains the same, but this organization presently looks much different than it did the day Rev. Charlie Byers stepped into the studio in 1946. Over the past 78 years God has grown The Tide ministry from a local radio program on one station in central Pennsylvania to a multifaceted global outreach using a variety of broadcast media in over 30 languages to proclaim the good news about Jesus to people in 13 countries or regions. Ongoing strategic planning, grounded in prayer and an earnest desire to discern God's will, plays a vital role in the longevity, growth, and effectiveness of the Tide ministry. Our current Diamond Vision was unveiled in 2021 in conjunction with our 75<sup>th</sup> anniversary. As we approach our 80<sup>th</sup> year of gospel proclamation through broadcast media we are beginning to transition into The Tide Vision 2026 which focuses on the three key strategic elements of Partnership Development, Organizational Strength, and Resources Development.

We rely on our global ministry partners to accomplish our mission. They in turn rely on us for the resources to carry out that mission. Together, we are increasingly encountering spiritual warfare in our mutual endeavors to share the gospel. Our work in the Balkan region has experienced widespread opposition to both existing outreaches and efforts to expand into new countries. We are currently facing obstacles and challenges to route funds into India, Mozambique, and Pakistan. Almost every country in which we have a partnering outreach faces economic hardship. Seven of the thirteen countries where we have a base of operations are on the Open Doors World Watch list for persecution of Christians and four other countries are on the verge. As our partners face threats against their lives and facilities and engage in legal action to maintain or procure broadcasting licenses and registered organizational status, they turn to us for advice, assistance, encouragement and prayer support. As this spiritual battle rages on, the quarterly reports from the field come in with testimonies of lives changed by Christ and new fellowships being established! These victories indicate that God is sustaining the work and using our partners to draw people into His Kingdom.

As we continue to pursue the mission and vision that God has called us to, it is important to keep in mind how much the diverse aspects of Partnership Development and Resource Development integrate and coalesce with one another. Our efforts towards Resource Development often focus heavily on finances, but it is imperative that we also devote ourselves to providing prayer coverage, raising awareness, engaging in advocacy, and recruiting teams to visit each region and minister to - and alongside - our boots on the ground. We are grateful for the many congregations and individuals within the Allegheny Regional Conference who fill the dual role of partnering with us and generously providing resources. Thank you!

As we have grown, we have been making significant progress towards more robust operational policies and structure for improved Organizational Strength. Perhaps our greatest challenge is to discern how to best develop and establish Organizational Strength that can endure and adapt to multi-faceted changes in our environment and society. Longevity in ministry does not guarantee perpetuation, but it does indicate that we have historically been able to grow and adapt well. With God's help we hope to continue that trend as we continue to be fully devoted to our mission of creatively sharing the Good News of Jesus Christ worldwide through media and partnerships!



#### Awaken Report 2025

Awaken is fully invested in a vision of God's Kingdom reality, where our lived experience in the church reflects the biblical foundations of mutuality as women and men lead together, according to gifts and calling. We are a network for women in ministry, meaning, we function as a system of interconnected individuals that facilitates communication, and collaboration and as such, a component of the organized Church, working in a specific area of ministry leadership and calling.

In practice this happens as we work together to empower, engage, and equip women in ministry and leadership. We do that in various measures of networking, training, affirming, and inspiring through regional gatherings and virtual events. We have a mentorship program that offers one-on-one mentoring—by women for women—and cohorts (groups focused on specific goals). We have and continue to build an online resource Hub for all things related to women in ministry, and in these things, we advocate for women in ministry leadership.

This is long, slow work that requires creativity, innovation, and collaboration, because truthfully, the cultivation of church communities, where mutuality is the mark of our corporate (and personal) behavior, is still in process. I'm thankful for the decisions that we, as the Church, made this past summer at the General Assembly regarding the language in our Articles of Faith, which should help to reshape and form a more robust expression of what it means live and lead together, in the freedom of Christ (Galatians 3:28). But the kind of change we envision doesn't just happen, it takes intentionality and effort. We believe it's worth it, because the result will be a flourishing church where women and men serve shoulder to shoulder with mutual respect, trust, and partnership. My prayer is that we will collectively remember that that the harvest is great and understand that ministry is not a zero-sum game—we are better together.

Three years ago, Awaken began a cohort for women who are in the credentialing process. Working with Donna Sturr, the Assistant for Leadership Development, Awaken invites women who have received their 3-year provisional license into a cohort designed to encourage with mutual accountability, resources, and community around the common goal of writing the Doctrinal Questionnaire. This group of women from across the country meet every other week on Zoom for two hours as they work to accomplish this work. In addition to the Credentialing Cohort, Awaken initiated a Leadership Cohort, which focuses on Spiritual Formation and developing a leadership plan. This group meets monthly around assigned readings on topics like identity, spiritual disciplines, leadership, and discernment.

These are some of the practical ways we are working to help move the dial regarding our collective priority is to see an increase in the number of qualified women and people of color serving in BIC U.S. assigned ministry roles and governing boards (Project 250). This collective goal sounds good, but the reality of achievement is challenging when the pool to draw from is small. I reviewed some stats provided by the General Office and learned that over the last three years, the number of Ordained Female Ministers has increased. In this last year, five women were ordained, which is significant and worthy of celebration. We are encouraged by this movement, but also cognizant that there is still much work to be done. We press on.

As we look to 2025, we anticipate continued movement as we build and launch new iterations and ideas to help support a vision that emboldens women in ministry in the church. We are so very grateful for the privilege to partner with each conference. Your investment helps in significant ways as we work together for this purpose. Thank you.

The past year has been filled with exciting ways that God's faithfulness has been demonstrated in the work of Messiah Lifeways. We have again been recognized for our outstanding healthcare operations by Newsweek and U.S. News and World Report, as well as by having a deficiency-free annual survey conducted by the Pennsylvania Department of Health. We also received local recognition for Empowering Women by Lehigh Valley Business and Central Penn Business Journal and recognition of our leadership in our region by the Messiah University and the West Shore Chamber.

Messiah Lifeways At Home also celebrated 40 years of serving older adults in the community and was named a Provider of Choice by Home Care Pulse. Additionally, the renovations we recently completed on our Bailey Street Apartments were recognized by Senior Housing News for their architecture and design.

In November 2024, we were excited to ceremoniously break ground on our upcoming campus, Fernecrest, for those aged 62+, located at 100 Spanglers Mill Road in New Cumberland, Pennsylvania. This was a milestone moment for Messiah Lifeways, and our Fernecrest campus, as we hammered the first nail and turned the first shovel of dirt—breaking ground on the land that will soon become a vibrant community. Fernecrest will offer 15 floor plans, from spacious apartments to well-appointed courtyard homes, duplex homes, and estate homes. With 131 residential living units, Fernecrest will welcome new older adults to the Messiah Lifeways community.

While we're active in the planning and development of this project as it comes to life, at the same time we continue to invest in our already vibrant campus community at Messiah Village. We appreciate that we have received several state grants that will bolster the funding of these projects at Fernecrest, Messiah Village, and our senior centers.

In the past year, we also highlighted our community, our noteworthy recognitions, accomplishments, and aspirations in our re-launched magazine, Unscripted, which is broadly focused on redefining the conversations around aging in the region.

As the calendar turns to 2025, we continue to prioritize the work of our strategic initiatives to build a great place to work and live—improving the services we offer and growing the number of older adults we serve. #### **Report to the General Conference of the Brethren in Christ Church**

In June of 2024, I publicly announced that I will be retiring as president of Messiah University in June 2025, following the conclusion of the current academic year. So, after the privilege of serving 20 years in the presidency, this will be my final report to the General Conference on behalf of Messiah University. I have been incredibly honored by the opportunity to lead this outstanding Christian educational community. I have been equally blessed by the relationships that I have formed over the years with Messiah students, alumni, employees, parents, donors, friends—and with the members and leadership of the Brethren in Christ Church. Messiah's Board of Trustees, in collaboration with a 16-member presidential search committee which includes the BIC National Director (also comprised of trustees, alumni, faculty, staff, administrators, and the student body president), is currently engaged in a national search for the ninth president of Messiah University to faithfully advance our distinctive institutional mission.

Messiah started the 2024-25 academic year by welcoming our new provost, Dr. Christine J. Gardner, who comes to Messiah from her previous role as dean of the School of Graduate, Professional and Extended Studies, and as chair of the Department of Communication Arts, Theatre and Art at Gordon College in Wenham, Mass. The university started the new year with an enrollment of 2,218 total undergraduate students, including 564 new first-time students, as well as 774 total graduate students. This year we also educated more than 330 dual enrollment students, an exciting increase rooted in expanding partnerships with local and regional high schools—and the addition of specialized dual enrollment tracks in business, education and engineering.

Our School of Graduate and Professional Studies continues to develop new degree programs that meet employer and societal needs such as **new MBA tracks in Artificial Intelligence and Business Analytics**. We have also been partnering with regional school districts to help address the critical teacher shortage in Pennsylvania through the expansion of our Teacher Certification Initiative, designed to help emergency-certified educators earn their long-term certification, and our Educators for Tomorrow initiative, designed to help high school students explore an education career while earning college credit. We are additionally excited and currently recruiting for NEXT Steps—a two-year, four-semester residential certificate program designed to support academic, vocational, social and spiritual growth for students with intellectual disability.

The University continues to fulfill the goals and priorities of its institutional strategic plan, *University Rising:* the Strategic Plan for Messiah 2022-2025. Some important updates include:

- The completed construction of **the first phase of our "Warmer Welcome" campaign.** In October 2024, we dedicated Sawyer Pavilion, providing new, much-needed hospitality/concession areas at Starry Athletic Complex and the Witmer Family Lacrosse Stadium, providing new stadium seating and media facilities for Messiah Lacrosse.
- The development of new enhanced campus entrance, with construction planned to begin in spring 2025 for completion later this summer.
- A yearlong celebration and a dedicated campaign to honor 40 years of nursing at Messiah University that will upgrade our patient simulators and that will purchase a neonatal unit at the Macha Hospital in recognition of the long-standing partnership we have shared.

In closing, I invite you to pray for the Phipps family as we continue to transition to our next (post-retirement) phase of life, which will be centered in Lancaster, Pa. Kelly and I look forward to meaningful volunteering and service to the church. Throughout all of the challenges, changes and growth that we have experienced together in my last 27 years at Messiah—20 of those as president—I have remained thankful for your support and for God's faithfulness to Messiah University as we have lived out our mission together to educate students toward maturity of intellect, character and Christian faith.

### Navajo Mission Director's Report 2024

2024 was marked as a year of transition for the NBICM. In January, I assumed the role of Executive Director of the mission. We also transitioned several new staff members onto campus and placed people in new roles. Betsy Sonnenberg was selected as the new School Administrator and Youth Pastor, a role in which she has thrived.

The mission had 12 mission teams from March through October of 2024. They hosted numerous VBSs, completed work projects, and aided in the community with various outreach programs. This was a significant increase from the previous year's numbers in both the number of mission teams and the size of personnel in the teams. 2025 is poised to see another rise. A couple of areas to highlight amongst the teams are as follows. One team completed repairs on the two-story house foundation and repaired all damage from the summer flood in other buildings. A youth group aided at the Nageezi Chapter House and even went to Farmington to hand out food to a homeless encampment. From the teams, we had 20 salvations and numerous rededications. As well as we saw an increase in our Church's congregation size due to the encouragement of the teams.

This summer, the mission received a sizeable donation allotted to the community center's roof repairs and the installation of a new family park complete with picnic areas, a new playground, and a soccer field.

Nizhoni Christian Academy more than doubled in size this year. Our max capacity of desks for students was 25, and we have 26 students, with at least three on a waiting list for next year. This was a huge blessing, and we plan to increase the school's size in the coming years.


Two new outreaches were started, and they are both going very strong. Betsy began a youth night program on Thursday nights. This program started in March with three kids and, at its height during the summer, had more than 30 youth attending. We are looking at ways to continue to expand this program. The mission also started a food pantry program to ease the community's economic burden. To date, we have handed out over 1,000 boxes of food.

This year, we hosted multiple community outreaches, including our annual Christmas program, Fall Festival, Back to School bash, three additional community dinners, multiple basketball tournaments, Wreaths Across America, a week-long volleyball camp, and a two-week-long basketball camp.

This past year, I had the privilege of sharing at 10 churches, the General Assembly, the Midwest Conference Assembly, and the Accelerated Christian Education Leader's Summit. This has enabled us to spread the work of what the mission is doing and how people can aid us in continuing to spread the good news.

When she moved into Pacific Lifeline's shelter, Lori started taking classes at Chaffey Adult School to get her high school diploma, worked on her resume, and started her job search. She then completed her goal of getting off probation and getting her charge reduced from a felony to a misdemeanor. This helped her obtain employment (her first real job in 20 years) at a local grocery store. She continued to take online courses to earn her high school diploma. With her steady employment, she started working on budgeting, saving, building her credit, and looking for housing. She has celebrated two years' sobriety.

Cassie's initial goals were to work on budgeting, go back to school to earn her LVN license, and improve her credit. She found affordable childcare and restarted her nursing program. She was awarded the Soroptimist Live Your Dream Scholarship to help with her school expenses. She completed her clinical hours, graduated, and obtained her LVN license. She got a full-time job as an in-home nurse and started working on budgeting, saving, financial literacy, and improving her credit score. She then found full time employment as an LVN at Kaiser. She is currently working on transitioning into permanent housing.

"I am thankful for Pacific Lifeline. They are so much a part of my life. God has used Pacific Lifeline to reach so many hearts. Pacific Lifeline is a place of love, even if tough: it's out of love for the person. Growth is what they go through with you. There were times when I felt so overwhelmed, but literally Pacific Lifeline has been there. Thank God for Pacific Lifeline and their staff. God bless them in everything they do. They are my angels here on earth. I will be forever grateful for Pacific Lifeline.



Families come to Pacific Lifeline from really dark places. But at Pacific Lifeline, they are surrounded by God's hands, love, and light. He is everywhere. I painted God's hands in different hues of gold because Pacific Lifeline is like gold to me."





Pacific Lifeline's shelter houses five families at a time. Each family stays for up to two years. Pacific Lifeline's Next Step program includes two homes offered at reduced rent to two additional families. Constructed in 2024, our new duplex (pictured above) will soon house two more families (with reduced rent and support services).
